(3) At the time of closing the auction, the highest bidder will have to deposit 25 percent of the bid amount as initial deposit through pay order/demand draft, otherwise his EMD will be forfeited. The EMD paid will be adjusted in the down payment amount. EMD of unsuccessful bidders will be returned at the time of auction.
