1. Technical Requirements

- Complete diagnostic testing of Fire Alarm Panel, Sensors, Hooters, Battery and Wiring.
- All fire-sensitive areas must be covered by Smoke / Heat Detectors.
- One internal & one external hooter must be installed, audible across premises.
- All sensors must conform to ISI / BIS / ERTL / UL / LPCB / VDS.
- Minimum 8-hour battery backup with self-charging.
- System must connect to branch UPS where available.
- Fire Panel must support GSM Auto-Dialer (min. 5 numbers).
- Vendor must provide system diagram & installation report after commissioning.
- FRLS wiring & ISI conduit must be used.
- All installation must meet IS 2189:2008 standards.

2. Terms & Conditions

1. Installation must be completed **within 48 hours** of RO/branch order.
2. Installation charges must be **all-inclusive** (wiring, labour, transport).
3. GST will be paid extra as applicable.
4. Defective parts must be replaced only after **written approval** from RO Mainpuri.
5. Delay beyond 48 hours will attract a **penalty of ₹200 per day**.
6. Payment will be released within **15 working days** after invoice + installation report.
7. Dedicated communication/contact system must be maintained by vendor.
8. Technician must carry valid ID and follow branch entry protocol.
9. Vendor must follow BIS fire-safety standards (IS 2189:2008).
10. Bank reserves full right to accept, reject or modify any part of the tender.
11. Bank may terminate the Rate Contract at any time without assigning a reason.

3. Security Deposit

- A **Security Deposit of ₹10,000/-** must be submitted through DD / Pay Order in favour of *Uttar Pradesh Gramin Bank*, payable at **Regional Office Mainpuri**, within **15 working days** of work allotment.
- Retained till completion of contract; **no interest** payable.
- Will be **forfeited** if vendor:
 - refuses allotted work,
 - delays installation,
 - provides unsatisfactory services.

4. Eligibility Criteria

- Minimum **₹10 Lakhs turnover** in fire-alarm or security-system related work.
- Minimum **3 years experience** in PSBs / RRBs / Government institutions.
- Vendor must submit **PAN, GSTIN, Registration documents**.
- Vendor must not be **blacklisted** by any Bank / PSU / Govt. Body.
- All supplied products must meet certification standards.

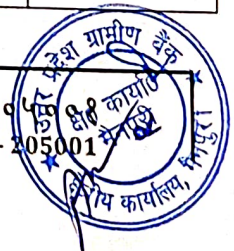
