ADDENDUM

Printing of Wall Calendar for Year 2026 for Uttar Pradesh Gramin Bank

GeM Bid No. GEM/2025/B/6939677 dated 27.11.2025, Pre-Bid Meeting held on 10.12.2025 at 11:00 AM.

Sr. No.	Query Raised	Bank's Response
1	Similar work experience to be considered only in Scheduled Banks, NBFCs and Financial Institutions.	The RFP specifies that similar work experience must be from Scheduled Banks, NBFCs, or Financial Institutions. In addition, Government (Central/State) institutions shall also be considered under similar work experience.
2	Request to relax fixed work order value limits and 3-year restriction.	The minimum order value criteria and the requirement that similar work must be completed in the last 3 years are essential eligibility conditions and no relaxation is permitted. Composite bills/invoices of the same work of similar nature will be considered for meeting the order value criteria.
3	Whether exemption for MSME is provided in the tender.	Exemption is available as per GeM GTC and MSME Act. Only MSE manufacturers / service providers are eligible. Traders are not eligible. Valid and applicable documents must be uploaded by the bidder.
4	Clarification on scope: Whether quantity is 64,000 x 5 or 3,20,000 calendars.	The total quantity specified in the GeM Bid is 3,20,000 Wall Calendars. The mention of "6 sheets (both-side printing)" pertains only to the printing/design format and does not affect the quantity. As this is a BOQ bid, the overall quantity of 3,20,000 calendars has been divided into 5 lots of 64,000 calendars each for operational purposes. The final quantity to be supplied remains 3,20,000 units.
5	Detailed dispatch locations not provided in RFP.	Dispatch will be to 65 Regional Offices of the Bank. The detailed dispatch list shall be provided to the successful bidder before supply.
6	Whether only calendar printing work will be considered or other printing jobs also.	Similar work includes printing-related assignments of comparable nature and scale, executed for Scheduled Banks, NBFCs, Financial Institutions, or Government institutions. The work must satisfy the minimum bill value criteria as per the RFP.

Note:

- All other terms and conditions of the RFP and GeM Bid No. GEM/2025/B/6939677 dated 27.11.2025 remain unchanged.
- The last date of submission of bids on GeM shall remain unchanged i.e. 18.12.2025.
- This Addendum forms an integral part of the RFP.
