### **Eligibility:**

1. The firm/company should have a minimum of 3 years of experience in the field of Non-Comprehensive Annual Maintenance Contract of CCTV and Alarm Systems in PSBs, financial institutions, government organizations, or any reputed organization. (Enclose certified copies of relevant documents).
2. The firms/companies should have been registered with Sales Tax Department for work contract and shall provide PAN and GSTIN No. with the bid. (Without which the vendor's bid would become invalid and same shall be rejected).
3. The firms/company must have an average minimum Turnover of 7 (Seven) lakh in Three financial year (2022-23, 2023-24 & 2024-25), the bidder must submit the supporting document duly stamped and signed by C.A along with UDIN.
4. Firm/Company must have strong support of technical staff to resolve calls within 24 hours.
5. The Firm/Company should not have been blacklisted by any public sector/Bank/PSU/Government Department in the past. A Self declaration letter by the bidder, on the company's letter head should be submitted along with bid.
6. The selected bidder shall submit a Security Deposit of ₹10,000/-, in the form of a DD/Banker's Cheque/Pay Order drawn in favor of "Regional Manager, Uttar Pradesh Gramin Bank, Regional Office Mahoba". Security Deposit must be submitted within 7 (seven) days of receiving the work order. Security deposit will not carry any interest.
7. The bidder should be a registered firm/company under: Companies Act, or MSME/NSIC registration, or Partnership firm registration, etc. (Document proof to be attached.)
8. The Firm/Company should have a service/support office in the Mahoba/Hamirpur/Kanpur/Banda for faster service response. (Submit office address & proof).

### **Other Conditions:**

1. The contract will be effective for a period of one year from the date of allotment of contract. The bank shall have the right at its sole and absolute discretion to continue the assignment/contract of the selected bidder for future requirement for various items/activities as described in RPF after expiry of contract period.
2. The contract will be for non-comprehensive on-Site Maintenance.
3. Replacement of Parts will be paid by bank with original spares of the brand make model of the CCTV & ALARM System with the best quality spares as mentioned in quotation. Non-comprehensive Annual Maintenance vendor should keep sufficient spares at the office and should provide standby CCTV & ALARM System if needed a reasonable period and in no case more than 24 hours.
4. The firm/company must provide at least 2 (Two) dedicated resident (Mahoba/Hamirpur) Service engineer/Technician; they should be available to branches for managing all the service requests logged by our branches on all working days of bank. If in case presence of any of the service engineer is not possible, another engineer should be provided in his/her by the firm/company.

It shall be responsibility of the firm/company to make all CCTV & ALARM System work satisfactorily throughout the contract period and to hand over the system in working condition to the bank after expiry of the contract. In case any damage is found, the firm/company will be liable to rectify it even after expiry of Non-comprehensive Annual Maintenance contract.

8. **Availability service level & Penalty** – In case any engineer is not available the Bidder should immediately provide the Bank with an equivalent standby engineer for that period of unavailability.
9. If the bidder fails to resolve any reported issue within **48 hours** during any month, the bidder shall be liable to pay a **penalty of Rs. 250 per day** until the issue is fully resolved.
10. Upon expiry of the notice period, the AMC shall stand terminated, and the Security Deposit shall be forfeited and will not be refunded to the bidder.
