ANNEXURE-XIX

Consent Letter Given by the Landlord

I hereby give my consent to the following:

1. I propose to lease the ground floor/first floor of my building premises to **Uttar Pradesh Gramin Bank, Branch:**, **District:** at a rental rate of Rs. per square foot. The premises is located at Village/Mohalla:, Post:, District:, having a carpet area of sq. ft. After discussions, I agree to lease out sq. ft. of carpet area to Uttar Pradesh Gramin Bank for a period of 10 years at a monthly rental of Rs. calculated at the rate of Rs. per sq. ft., subject to the bank's terms and conditions. The rent will be increased by% after 5 years. I also agree to execute a lease deed, and I will bear 50% of the total expenditure incurred for the same.
2. I have been informed that the rooftop of the proposed building will be used by the bank for installing V-SAT, monkey cage, and solar panels, for which no additional rent/charges will be payable. I hereby express my consent for the same.
3. I have no objection to the installation of air conditioners by the bank in the premises. The bank may fix wooden/iron frames on walls or other parts of the building at its own expense. No rent/charges will be payable for this purpose.
4. I will provide space near the branch premises, free of cost, for the installation of earthing pits and generator.
5. I will provide parking space, without any additional cost or rent, for bank staff, customers, and authorized persons of the branch. I also agree not to lease out the space in front of the branch gate to any individual or organization for any purpose. The bank will have full rights to use it for any of its own purposes.
6. The bank may install an ATM inside or outside the branch premises, for which no additional rent/charges will be payable.
7. The bank will have the right to install signboards/indicator boards inside, outside, or on the roof of the branch premises without any rent/charges.
8. I also agree that the bank may install any other equipment/devices inside, outside, or on the rooftop of the branch premises without any rent.
9. I will ensure proper maintenance of the branch premises, including repairs, upkeep, and painting/whitewashing of walls, doors, and windows every 2-3 years.
10. I shall not lease any part of the building premises to any other bank for banking purposes.
